### Key Highlights:

*Nigeria's Merchandise Trade grew as imports increased significantly and showed a marginal growth in export, resulting in an unfavorable trade balance in Q3, 2021:*

Total Trade increased by 10.43% in Q3, 2021 compared to Q2, 2021 and 58.59% year-on-year.

### IMPORTS

Total Imports value stood at N8,153.79 billion in Q3 2021 was 17.32% higher than Q2 2021 and 51.47% higher than Q3 2020.

- The value of Imported Agricultural goods was 21.01% higher than the value recorded in Q2, 2021 and 56.74% higher than Q3 2020.
- The value of Raw Material imports was 9.08% more than Q2, 2021, and 29.06% more than the value in Q3 2020.
- Solid Minerals imports in Q3 2021 increased by 10.93% compared to Q2 2021 and 53.42% compared to Q3 2020.
- Energy goods imports in Q3 2021 were 408.51% more than Q2 2021 and 24.14% more than Q3 2020.
- Manufactured goods imports value was 13.98% higher in Q3 2021 than the level in Q2 2021 and 42.73% more than Q3 2020.
- Oil products imports value was 34.60% more than in Q2 2021 and 113.18% higher than Q3 2020.

### EXPORTS

The value of Total Exports stood at ₦5,130.30 billion in Q3, 2021 representing an increase of 1% over Q2 2021 and 71.38% over Q3 2020.

- Agricultural goods export value in Q3, 2021 was 5.9% lower than Q2 2021 but 31.0% higher than Q3 2020.
- Raw Material exports value increased by 135.2% in Q3 2021 against the level in Q2 2021 and 1,241.1% higher than Q3 2020.
- Solid Minerals exports value in Q3 2021, increased by 22.7% compared to Q2 2021 and 222.8% compared to Q3 2020.

## -Q3 2021



- Energy goods exports value in Q3 2021 was 58% lower than Q2 2021 and 34.5% lower than the value in Q3 2020.
- Manufactured goods exports were 39.4% more than the value in Q2 2021 and 121.6% higher than Q3 2020.
- Crude Oil exports in Q3 2021 were 1.3% lower than the value recorded in Q2 2021 but 66% higher than Q3 2020.
- Other oil products exports in Q3 2021 were 3.6% more in value than in Q2 2021 and 57.8% higher than Q3 2020.



## 1.0 Overview

Total Exports in the third quarter of 2021 were recorded at N5,130.30 billion, which shows a 1% growth compared to the second quarter of the same year and a 71.38% growth compared to the third quarter in 2020. Total Imports in the reviewing quarter, in contrast, increased to N8,153.79 billion showing an increase of 17.32% quarter on quarter and 51.47% on a year-on-year basis.

Nigeria Trade Balance in Q3 2021 amounted to a deficit of N3,023.50 billion showing an increase of 26.53% year on year resulting from a continued increase in imports.



Export in the third quarter 2021 was still oil-dependent. Crude oil exports recorded N4,026.18 billion and it remained the major product in total exports (78.48%), while non-crude oil was valued at N1,104.1 billion or 21.52% of total exports of which Non-oil products only contributed N546.27 billion representing 10.65% of total exports during the quarter under review.






## 1.1 Imports Classified by Standard International Trade Classification and Country of Origin


Nigeria's imports trade stood at N8,153.79 billion in Q3 2021. According to Standard International Trade Classifications, imports of machinery & transport equipment stood at N2,753.66 billion (33.77%) while imports of Mineral fuel amounted to N1,501.80 billion (18.42%). Chemicals and related products contributed N1,418.62 billion (17.40%) and Food and live animals was valued at N 1,124.57 billion (13.79%).

In the reviewing quarter, most imported products were from Asia, Europe and America, these regions contributed 51.12%, 33.48% and 11.30% of the total imports respectively. Nigeria's import trade by direction showed that imported goods were mostly from China, India, the USA, Netherland and Belgium, which respectively accounted for 29.95% (N2,441.79 billion), 8.71% (N710.35 billion), 7.35% (N599.12 billion), 6.80% (N554.23 billion) and 5.32% (N434.11 billion). China remained the top importing partner for Nigeria in Q3 2021, this was followed by India. Import from Africa accounted for N247.66 billion (3.04%) while import from the Economic Community of West African States (ECOWAS) accounted for N26.69 billion of the total imports value from Africa during the period under review.

Import by Country (N'billion)






## 1.2. Exports Classified by Standard International Trade Classification and Country of Destination

The structure of the export trade was still dominated by crude oil exports which contributed ₦4,026.18 billion (78.48%) to the value of total exports in Q3, 2021. Exports by Section revealed that Nigeria exported mainly mineral products, which accounted for ₦ 4,605.25 billion (89.77%) of the total export value. This was followed by Vehicles, aircraft, and parts which contributed N195.16 billion (3.80%) to the total exports.

In third quarter 2021, Nigeria exported products were mostly to Europe (N2,230.10 billion), Asia (N1,480.58 billion), Africa (N668.22 billion), and America (N625.68 billion). Among exports to Africa, N346.8 billion (51.90%) of goods were exported to ECOWAS countries. In terms of country of destination, India remained the top exporting partner for Nigeria in the reviewing quarter. The five top exports partners are India, Spain., Italy, France, and the Netherlands, whose values stood at N758.18 billion (14.78%), N627.01 billion (12.22%), N446.04 billion (8.69%), N363.23 billion (7.08%), and N242.49 billion (4.73%) respectively. These five countries accounted for 47.50% of the total exports in Q3, 2021.



### Import and Export By Region (N'billion)







## 2.0 Exports and Imports Products Classified by Sectors Q3, 2021

### 2.1 Agricultural Goods Sector

The total value of trade in agricultural goods in Q3 2021 stood at N868.5billion; these comprised of agricultural goods exports (N79.4billion) and agricultural goods imports (N789.1billion). Agricultural goods exports value in Q3, 2021 was 5.9% lower than Q2 2021 but 31% higher than Q3 2020. The value of imported agricultural goods was 21.01% higher than the value recorded in Q2, 2021 and 56.74% higher than Q3 2020. During the quarter, agricultural goods exports were driven by good fermented Nigerian cocoa beans worth N27.2billion, of which N9.7billion, N6.18billion and N5.7 billion were exported to Indonesia, Malaysia, and the Netherlands respectively. Other products exported under this sector were superior quality raw cocoa beans worth N11.13billion of which exports to Malaysia was valued at N11.1billion; Sesamum seeds (N8.86billion) and Cashew nuts (N7.27billion) exports of which N3.7billion and N6.6billion were exported to Japan and Vietnam respectively.

In terms of imports, Durum wheat worth N88.46billion and N86.75billion were imported from the United States and Russia respectively, Mackerel worth N30.69billion were imported from Russia, and crude palm oil worth N35.14billion were imported from India.

### 2.2 Solid Minerals Sector

The total value of solid minerals trade in Q3 2021 stood at N72.4 billion. The export component stood at N18.3billion while the import component was valued at N54.1 billion. During the quarter, Solid Minerals exports increased by 22.7% compared to Q2 2021 and 222.8% compared with the corresponding quarter of 2020. On the other hand, Solid Minerals imports in Q3 2021 increased by 10.93% compared to Q2 2021 and 53.42% compared to Q3 2020.

Some of the products exported under this sector include Other Cement exported to Niger republic (N3.6billion) and Togo (N2.5billion). Zinc ores and Concentrates were exported to China in the value worth N3.3 billion and Lead ores and Concentrate worth N2.7 billion were also exported to China. In the same period, Gypsum worth N10.3 billion and N4.7billion were imported from Spain and Turkey. Other products imported include; Plasters of Calcined Gypsum imported from Turkey (N3.2 billion) and Tunisia (N2.5billion). There were other Coals imported from Mozambique and Brazil in values worth N5.6billion and N2.1 billion respectively.

### 2.3 Manufactured Goods Sector

The total value of trade in manufactured goods stood at N5,195.6billion in Q3,2021. The export component of this trade was valued at N295.03billion while the import component stood at N4,900.5billion. During the reviewing quarter, manufactured goods exports were 39.4% more than the value in Q2 2021 and 121.6% higher than Q3 2020. On the other hand, manufactured goods imports were 13.98% higher in Q3 2021 than the level in Q2 2021 and 42.73% more than Q3 2020.

The Products exported under this sector and their country of destination were; Floating or submersible drilling platform Cameroon (N159.3billion) and Equatorial Guinea (N4.4billion). During the review period, Aluminum alloys were exported to Japan (N14.2 billion) and China



(N5.4 billion). Oil cake and other solid residues to France (N12.7billion) and Helicopters were re-exported to Ghana (N12.9billion). Manufacturing imports in the reviewing quarter were; Used Vehicles worth N155.5billion and N7.0billion from USA and Italy. Motorcycles worth N70.2billion and N45.1billion were imported from India and China. Other products imported under this sector were; other Polyethylene terephthalates from China and India valued at N78.5billion and N19.1billion respectively. Machines 4 the reception, Conversion and transmission valued at N67.7 billion and N7.6billion were imported from China and Sweden and Polypropylene worth N32.6billion, N23.7billion and N12.4billion were imported from Saudi Arabia, South Africa and China respectively.

#### **2.4 Raw Material Goods Sector**

The total value of trade in raw materials in Q3 2021 stood at N1,067.36 billion. The export component was valued at N150.57billion and the import component stood at N916.79 billion. Raw material exports increased in value by 135.2% in Q3 2021 against the level in Q2 2021 and by 1,241.1% year on year. On the import side, the value of Raw material imports was 9.08% more than the value recorded in Q2, 2021 and 29.06% more than the value in Q3 2020.

The products exported under this sector among others include; Urea exported to Brazil and Argentina in values worth N92.16billion and N14.3billion respectively. Technically specified natural rubber was exported to France in the value worth N2.16billion. Other products exported under this sector were Leather exported to Spain (N5.46billion) and Italy (N1.17billion). Gum worth N6.89billion was exported to Brazil during the period under review. In terms of imports, Cane sugar worth N129.98billion and N5.39billion were imported from Brazil and Andorra, respectively. Milk preparations worth N27.03billion, N6.34 billion, and N2.85billion were imported from Ireland, Malaysia, and France respectively. Other products imports were Mixtures of Odoriferous substances from Ireland (N16.68billion) and Swaziland (N9.13billion). Also mixed alkylbenzene worth N29.74billion was imported from Spain and Mixtures of odoriferous substances worth N7.34billion and N4.07billion from Indonesia and India.




Trade by Sector (N'billion)




## 3.0. Trade Intensity in Q3 2021

### 3.1 Export Intensity Index with Nigeria Major Trading Partners

The Export intensity index compares the share of exports to each country in Nigeria’s total exports with the share of world exports going to that country, and therefore gives a measure of the importance of that country to Nigeria as an export destination. A higher number denotes a stronger relationship, and an index of one indicates that exports to that country are what would be expected given global trade patterns.

The Export intensities of Nigeria in Q3 2021 showed Nigeria had a strong export relationship with India, with export intensities of 7.02, 8.06, and 4.07 for July, August, and September 2021 respectively. Spain also recorded a relatively high export intensity index than the other three major trading partners of 8.19, 5.33, and 3.86 in the three months of the third quarter respectively. Italy recorded export intensities of 5.70, 2.82 and 2.97 for July, August, and September and France recorded 1.49, 2.14 and 2.31 for the same period. There was a downswing of 0.54 in July for the Netherlands and an upswing of 1.08 and 1.88 for the same Netherlands in August and September.






## 3.2 Import Intensity Index with Nigeria Major Trading Partners

During the quarter, the import intensity of Nigeria with the top five importing partners showed a similar pattern to the exporting intensity with the index stronger in all the months except for the USA. India with the record of 5.50, 6.50, and 4.42 for July, August, and September, showed the highest importing intensity for the three months, followed by Belgium with (2.56, 2.17 and 1.18), Netherland with (1.99, 1.65 and 1.28) and China (1.56, 1.84 and 1.98).

## 4.0 Trade by Mode of Transport

In Q3 2021, Nigeria's major mode of transporting its goods to partner countries was by Maritime. Transport of exports goods by Maritime accounted to N5,088.55billion (99.19%) of total export. The goods exported through road transport were valued at N14.42 billion or 0.28% while goods exported through the air transport amounted to N24.4billion (0.48%). For import trade, the major mode of transporting goods into the country was through Maritime transport. Maritime transport accounted for N7,738.4billion (94.91%). Goods that entered the country through road transport accounted for N40.18 billion (0.49 %) while those through Air transport accounted for N375.19 billion (4.60 %).

## 5.0 Trade by Custom Ports and Post

The leading port of operation during the quarter was the Apapa Port. Goods worth N4,669.64 billion exited the country through this port. The next leading port of operation was Port Harcourt (3) through which goods worth N307.38billion were shipped to partner countries. Tin can Island was also very active and goods worth N103.77billion exited the country through the port. Other active ports in operation during the period were Muhammed Murtala International, Sokoto Area Command, Port Harcourt (1), Seme Border Post, Calabar Port, and others. Similarly, goods that entered Nigeria through Apapa Port were valued at N4,439.78billion, Tin can Island at N1,238.76 billion and Port Harcourt (3) at N865.95 billion, respectively

## Methodology

The National Bureau of Statistics publishes this Trade statistics report on quarterly basis. Trade statistics compilation by NBS is largely from secondary data source.

## Data Sources

The data sources for the compilations include; The Nigerian Customs Service (NCS) through the Nigeria Integrated Customs Information System (NICIS), Nigerian National Petroleum Corporation (NNPC) and various oil companies in the upstream and downstream sectors of the oil industry, Nigerian Ports, Petroleum Products Pricing and Regulatory Agency (PPPRA), Nigeria Liquefied Natural Gas Ltd (NLNG), Central Bank of Nigeria (CBN), Neroli Technologies Ltd, Gojopal Nigeria Limited, Anglia International Limited, Nigerian Export Processing Zone Agency (NEPZA), Oil and Gas Free Zone Agency (OGFZA) Nigerian Electricity Regulatory Commission (NERC), Federal Airports Authority of Nigeria (FAAN), Nigeria Civil Aviation Authority (NCAA) and Nigerian Ports Authority (NPA)

## Validation & Quality Assurance:

After collecting data from the above stated sources, they're screened and verified for outliers. Data validation is undertaken through a sample of the various Nigerian Customs Service outposts in Nigeria. Weight harmonization is also carried out through the various entry ports in Nigeria

## Processing and Analysis:

Data processing is done using the Global Eurotrace software and the processed data is banked in the trade database. Standard International Trade Classification (SITC) is used to classify and categorize trade items.

## Definitions:

- **Domestic exports** - These are goods grown, extracted or manufactured in Nigeria and are sold in another country



- **Re-export** – These are goods of foreign origin which entered Nigeria to be consumed but are subsequently sold to another country without any substantial transformation. In other words, they are exported in the same condition as imported.
- **Raw material goods** – These refers to products of Agriculture, forestry, fishing and any other mineral that are in its natural form or which has undergone the minimal transformation required to prepare it for international marketing.
- **Agricultural goods** - These are goods that come from the planting of crops and/or rearing of animals.
- **Solid minerals** – These are elements found in the earth. These are naturally organic substances that are solid like precious stones, kaolin etc.
- **Energy goods** -These only refers to fuel woods in logs, for example hard wood, charcoal, coniferous wood in chips or particles etc.
- **Manufactured goods** -These are tangible goods created from the conversion of raw materials into consumable or useful products.
- **Other Petroleum products** -these consists of mineral fuels like Natural gas, oil, Bituminous coal etc.
- **Crude oil**- These are naturally occurring, unrefined petroleum products composed of hydrocarbon deposits and other organic materials.

**Trade Intensity Index** -The trade intensity index is used to determine whether the value of trade between two countries is greater or smaller than would be expected based on their importance in world trade. It is defined as the share of one country's exports going to a partner divided by the share of world exports going to the partner.
