



Strong Merchandise Trade Growth in Q2 2013:

Export growth outperforms imports leading to favourable trade balance.

Total Merchandise Trade

The total value of Nigeria's external **merchandise** trade amounted to N5,341.1 billion in the second quarter 2013, an increase of N242.3 billion or 4.8% from N5,098.9 billion recorded in the previous quarter. This change resulted from an increase in the value of exports from N3,452.1 billion in the first quarter of 2013 to N3,742.9 billion in the second quarter (an increase of N290.8 billion or 8.4%), and a 2.9% decline in the value of imports from N1,646.7 billion in the first quarter of 2013 to N1,598.2 billion in the second quarter. Furthermore, the increase in exports and decrease in imports resulted in a favourable **trade balance** of N2,144.7 billion in the second quarter, an increase of



N339.3 billion or 18.8% from levels recorded in the First Quarter of 2013. Further analysis with the second quarter of the preceding year indicates that the value of the nation's total merchandise trade decreased by N1,742.8 billion or 24.6%, while the trade balance also declined by 49.7% as imports increased by 13.5% while exports decreased by 34.1% year on year (See imports and Exports Sections below for more information). The **Crude oil** component of the total trade stood at N2,709.4 billion, a decrease of N321.2 billion or 10.6% when compared with the previous quarter. Year-on-year, the crude oil component recorded a 23.6% decline. The Value of total trade for the First half of the year 2013 was N10,440.0 billion decrease of N3266.0 or 23.8% compared to N13,706.0 billion recorded in the same period of the preceding year (Table1).

Imports Classified by Standard International Trade Classification and Country of Origin.

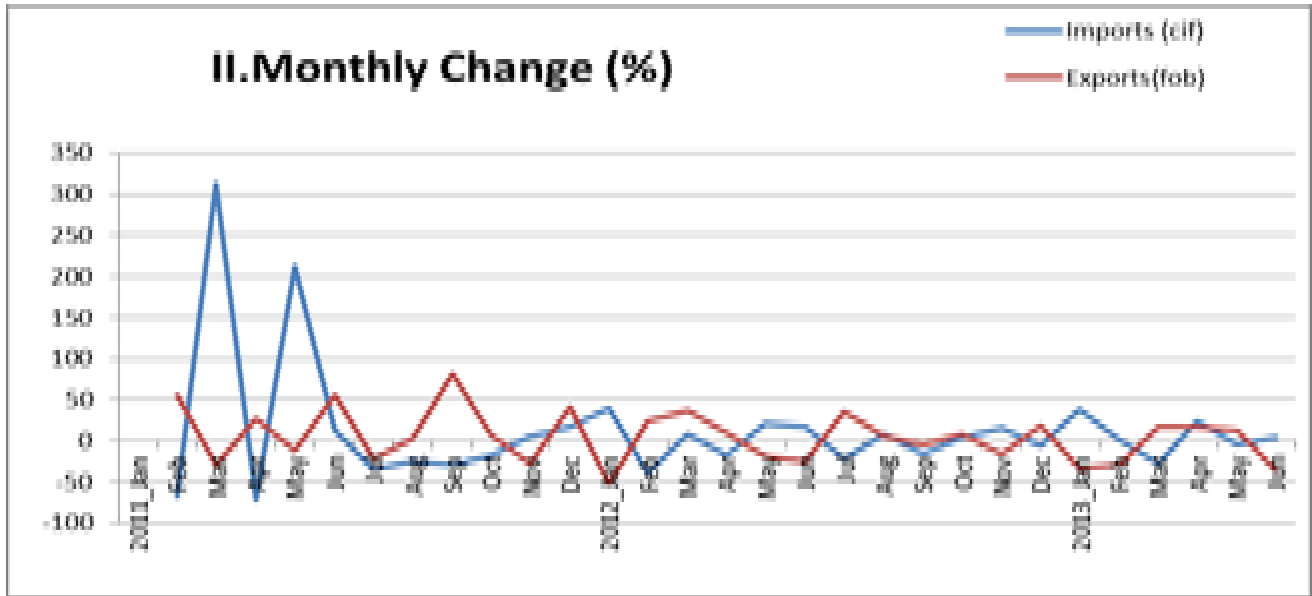
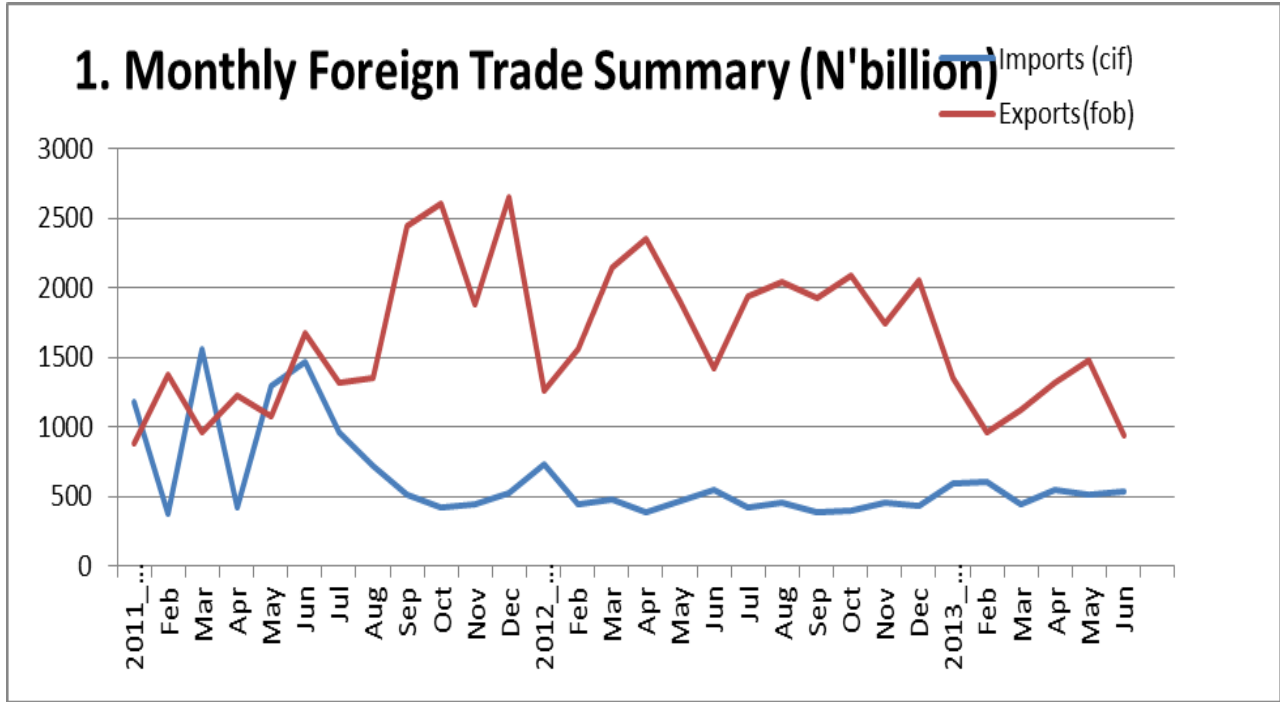
The value of Nigeria's imports stood at N1, 598.2 billion in the second quarter of 2013 a decrease of N48.5 billion or 2.9% from N1, 646.7 billion recorded in the first quarter. In the second quarter of 2013, the value of imports increased by 13.5% year-on-year. For the first half of the year, the total value of imports, stood at N325.0 billion a 6.0% increase from N3,060.7 billion recorded in the corresponding part of the previous year. The decline of imports in the second quarter 2013 relative to the first quarter of the year resulted from the decline of some products classified according to SITC such as Crude Inedible Materials which accounted for N12.2 billion or 0.8% of total imports, Oil and fats at N1.2 billion or 0.1%, Mineral fuels at N14.2 billion or 0.9%, and Beverages & Tobacco with N6.7 billion or 0.4% of total imports. Details of imports classified by sections showed that Footwear, Head Gear, and Umbrellas accounted for N4.7 billion or 0.3% of total imports, Miscellaneous manufactured articles accounted for N7.0 billion or 0.4%, Mineral products were recorded at N254.7 billion or 15.9% and Vehicles, Aircraft and parts at N89.4 billion or 5.6%. The Nigerian imports according to Broad Economic Category revealed that Consumer goods (nec) accounted for with N55.7 billion or 3% of total imports, Transport Equipment and Associated Parts accounted for N57.8 billion or 4%, and Food and Beverages were recorded at

N147.5billion or 9% (Table7). A summary of Nigeria's imports by region showed that Asia ranked highest with N672.8billion or 42.1% of total imports, Europe recorded N584.6billion or 36.6%, followed by The Americas at N211.5billion or 13.2%, while Africa stood at N119.4billion or 7.5%. Out of the total imports from Africa, ECOWAS countries contributed N59.7billion or 50%. (Table4)

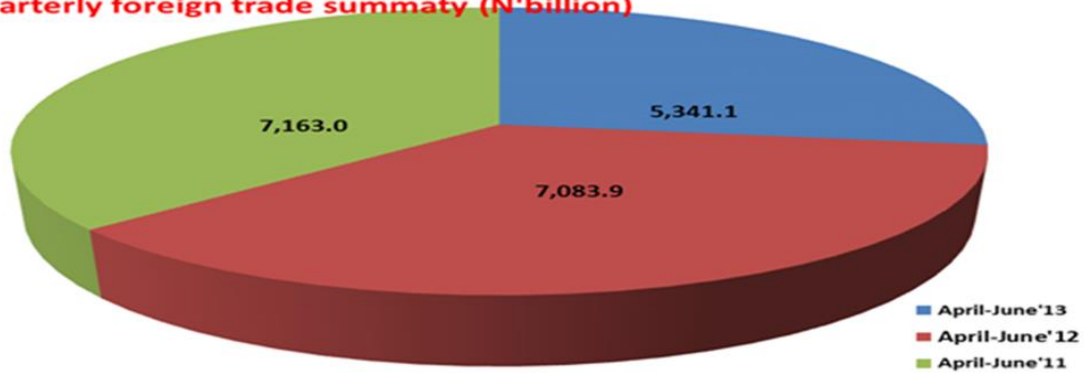
Exports Classified by Standard International Trade Classification and Country of Destination

The value of Nigeria's export totalled N3,742.9billion in the second quarter of 2013, an increase of N290.8billion or 8.4%. from N3,452.1 billion recorded in the first quarter 2013. Further analysis on a year-on-year basis revealed that export decreased by N1,932.6billion or 34.1% in the second quarter 2013. The value of exports in the first half of 2013 was recorded at N 7,195.0 billion, a decrease of N3450.2billion or 32.4% from N10,645.2 recorded in the first half of 2012 (Table1).

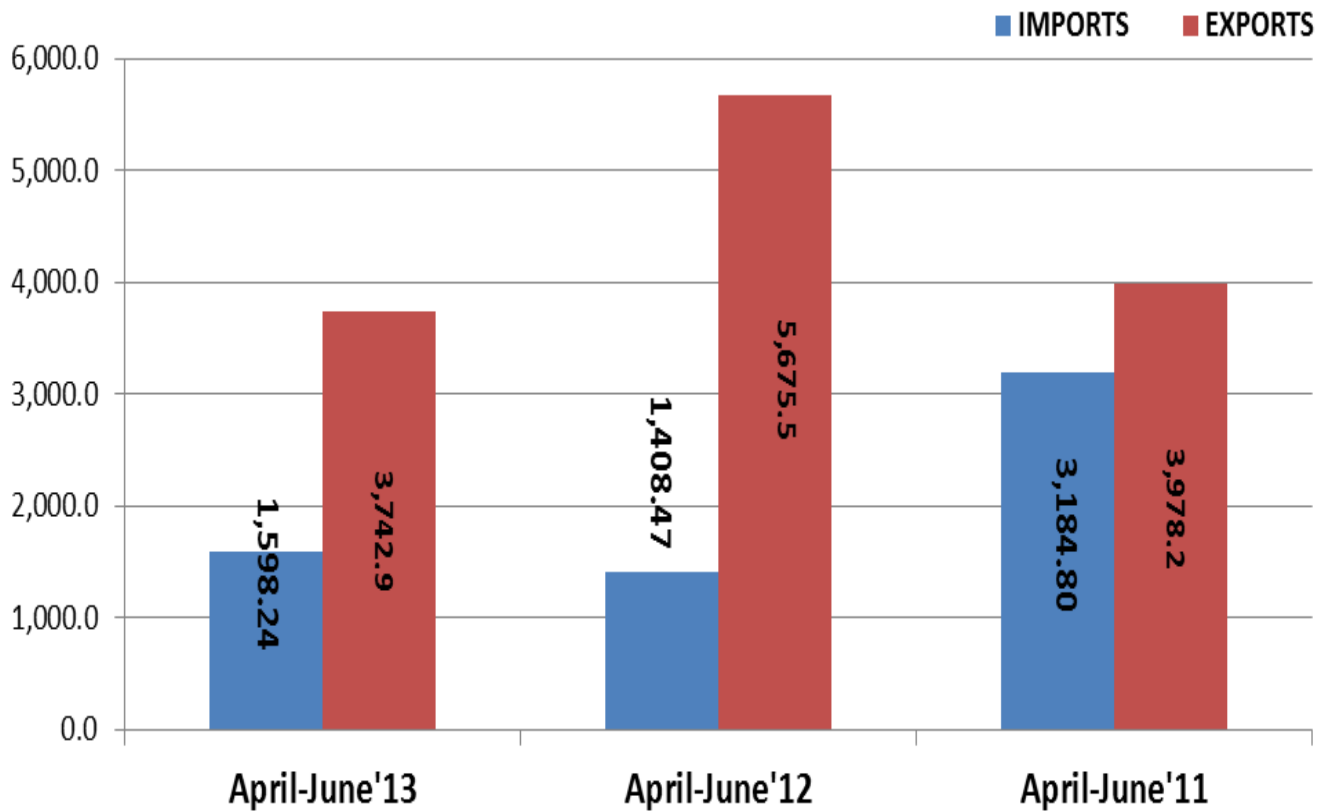
Analysis of exports by section reveals that Mineral Products contributed N3,122.1 billion or 83.4% of total exports. This was followed by Plastic, Rubber and Parts with N196.5billion or 5.2% , and Prepared Foodstuffs, Beverages, Spirit and Vinegar, Tobacco were recorded at N98.2billion or 2.6% (Table3). Exports to various continents indicated that Europe ranked first with N1,410.3 billion or 37.7% of total exports, followed by The Americas with N971.0billion or 25.9% , and Asia with N734.6billion or 19.6% . While Africa accounted for N503.8billion or 13.5% of total exports, ECOWAS contributed N218.5billion or 43.4% of exports to the region. Exports by Country of destination showed that Brazil took the lead with N443.0billion, followed by United States with N441.2billion, India with N359.4billion, France with N238.8billion and Italy with N227.5billion respectively.

Methodology

The National Bureau of Statistics publishes this Trade statistics report quarterly. Trade statistics compilation by NBS is largely from secondary data sources.

Data Sources:

The Nigerian Customs through the Nigeria Integrated Customs Information System, Cobalt International Plc (on export commodities), Nigerian National Petroleum Corporation and various oil companies in the upstream and downstream sectors of the oil industry, Nigerian Ports, Petroleum Products Price Regulatory Agency, Central Bank of Nigeria.

Validation & Quality Assurance:

After collecting data from the above sources, it is verified for outliers, Data validation is undertaken through a sample of the various Nigerian Customs outposts in Nigeria. Equally, regular visits are paid to the various outposts of Cobalt International for export validation using the extensive NBS field network. Weight harmonization is carried out through the various entry posts of imports and exports in Nigeria.

Processing/Analysis:

Data processing is done using the Global Eurotrace software and the processed data is banked in the trade database. We use the Standard International Trade Classification (SITC) to categorize trade items.
